**INSTRUCTIONS FOR CURIO OR
RELIC HANDGUN REPORT**

Reporting Requirements

Effective January 1, 1998, State law requires all California federal type "03" firearms licensees (collectors of curios or relics) who obtain curio or relic handguns while out of state to report such purchases or acquisitions to the Department of Justice within five days of transporting the handgun(s) into California.

Please use the reporting form on the reverse side. Make extra copies of this reporting form to meet your reporting needs. Do not use this form to report ownership of long guns. If you would like to voluntarily report ownership of a long gun, please use the Firearm Ownership Record form available on our web site at www.ag.ca.gov/firearms or by calling (916) 263-4887.

Please be aware that your failure to comply with this mandated handgun reporting requirement could result in your criminal prosecution (Penal Code section 12072(g)).

Form Completion Instructions

The completed form(s) must be returned with a **\$19.00** processing fee for **each** handgun reported (**e.g., 3 handguns x \$19 = \$57**). Payment must be made by check or money order payable to the Department of Justice. Mail completed form and fees to:
