I am writing in response to your fax requesting confirmation that the Lauer Custom LCW 15 Lower Receivers may be transferred/DROS'd to California residents.

This particular receiver is not listed as a Category I assault rifle in California Penal Code (PC) section 12276. Although technically the receiver is legal to purchase and possess at this time (assuming it does not have the characteristics listed in PC section 12276.1(a)(1), (a)(2), or (a)(3)), you should be aware that the LCW 15 lower receiver is virtually identical to rifles that are now listed as assault weapons by the Department, and is likely to be considered an assault weapon in the near future.
